“Scotland has produced its share of religious reformers and it is renowned for having canny financial managers, so it should come as no surprise that the \_\_\_\_\_ of Scotland has picked a famous American television \_\_\_\_\_ as a \_\_\_\_\_ for the new U.S. Bank. Pat \_\_\_\_\_ is to be the as-yet-unnamed bank’s face in the New World. He is the same right-wing former presidential candidate who last year \_\_\_\_\_ his Family Channel cable television assets to Rupert Murdoch for \$US1.9 \_\_\_\_\_. In choosing Mr. Robertson – descended from a Scots family that he says left the highlands in the same year this new banking partner was formed – Bank of Scotland has become a true \_\_\_\_\_. It sees that the \_\_\_\_\_ million Americans who regularly tune in to Mr. Robertson’s television show, The 700 Club, will be a handy bunch to have as \_\_\_\_\_.

When Mr. Robertson started his television \_\_\_\_\_ in the early 1960s he dug himself out of financial difficulty by staging the world’s first telethon and beseeching his viewers to pledge individual tithes of \$US10 a month. The money flow has not stopped, still coming in at annual rates of about \$US150 \_\_\_\_\_.

It could be a handy \_\_\_\_\_ of potential transactions for the new \_\_\_\_\_ on tap. Financial institutions increasingly are linking with cultural icons as they attempt to break into new territories. In the UK, Bank of Scotland’s rival Royal Bank of Scotland teamed up last year with Australia’s AMP and signed up Richard Branson and his Virgin brand for its new-age banking corporation. American \_\_\_\_\_ leaders have become hot \_\_\_\_\_ for such ventures, although the results have not always been as successful as their business partners have hoped.

The \_\_\_\_\_ of the National \_\_\_\_\_ Convention, Reverend Henry Lyons, last month was found guilty of racketeering by taking more than \$US 4 \_\_\_\_\_ from companies that were seeking to reach his congregation.” See note below.

“Pagan temples were either closed, transformed into Christian shrines or demolished. Their \_\_\_\_\_ were summarily \_\_\_\_\_ to the \_\_\_\_\_ patrimony. The wealth of sundry religions was mercilessly expropriated, their clergy dismissed or persecuted, when not civilly or even physically obliterated. The Bank, just inside St Anna’s gate is named the Institute for works of Religion... the IOR.

But it is a bank with several thousand customers and deposits amounting to about \$1,000 \_\_\_\_\_.” “Following the Lateran Treaty of 1929, the then reigning pope, Pius XI, set up a special agency to administer the \$ \_\_\_\_\_ million dollars which \_\_\_\_\_ Italy had put into the \_\_\_\_\_ coffers. With this agency the Catholic Church initiated a brand-new policy which has characterized her exertions ever since: that is one of \_\_\_\_\_ investments. It was a step which, although taking her along the dangerous road of international speculation, financial somersaults, and political risks, nevertheless within an astonishingly \_\_\_\_\_ time yielded \_\_\_\_\_ dividends.” **Avro Manhattan’s, Vatican Billions, page 128.**

“With the rise to power of Adolph \_\_\_\_\_ the papacy became a quick friend to protect their invested interests in Germany and to have a strong defender against \_\_\_\_\_ Russia. Hitler and the \_\_\_\_\_ signed a \_\_\_\_\_ in June 1933 only a few months after Hitler had become chancellor in Germany in January of 1933.

The Vatican went so far as to \_\_\_\_\_ the way for Hitler. The four great milestones of such policy were established **1.** When the leader of the German \_\_\_\_\_ party, Franz von Papen, was named Vice-chancellor of Nazi Germany, second only to Hitler in January 1933; **2.** When the Deputies of the Catholic party in Parliament voted for the \_\_\_\_\_ power to Hitler (March 23<sup>rd</sup>, 1933); **3.** When the Vatican gave orders to the Germans Centre party (\_\_\_\_\_ Party) to \_\_\_\_\_ itself, so as to remove political opposition to Hitler – which it immediately did on July 5<sup>th</sup>, 1933; And last but not least **4.** When the Vatican and Hitler signed the \_\_\_\_\_ in the summer of 1933. According to article 20 of this concordat, - “On Sundays special \_\_\_\_\_... will be offered...for the welfare of the Reich (Nazi Germany).” Even more serious was article 16: “Before \_\_\_\_\_ take possession of their diocese, they are to take an oath of fealty to the Reich \_\_\_\_\_.” **Avro Manhattan’s, Vatican Billions, page 134,135.**

The Vatican \_\_\_\_\_ invested in factories in Italy for the making of \_\_\_\_\_ and \_\_\_\_\_ for warfare and when the war started to look like turning against Hitler transferred much of their investments to Canada and especially the \_\_\_\_\_. This amounted to 700 to 800 \_\_\_\_\_ Italian lire at 1939 values. It has been estimated that immediately after the Second World War the Vatican investments in Europe were 3 billion Lire at 1939 values or 120 \_\_\_\_\_ at 1969 values of the lire. In Italy itself the estimated value of houses, buildings and land held by her through religious orders, religious institutes and the like would be 4,000 million lire at 1939 values or 190,000 \_\_\_\_\_ at the 1960 exchange. **Avro Manhattan’s, Vatican Billions, page 139.**

The Vatican has since its financial recovery in 1929 grown to the most powerful \_\_\_\_\_ power in the world with no rivals.
